Investec Mid-Market 100 Methodology : The Investec Mid-Market 100 ranks active, UK-registered companies on their four-year compound annual growth rate (CAGR) of turnover. Companies must be profitable throughout the four-year period. Over the four-year period, year one turnover must be a minimum of £1m; year four EBITDA must be at least £1m; year four turnover must be at least £10m. The ranking is based on filings on individual companies at Companies House and recorded on the Experian platform. The data analysis is conducted by Experian. Company financials are based on latest accounts, filed at Companies House by August 2016. The list is published twice yearly to provide a frequent, up-to-date snapshot of growth in the mid-market.
